## **NOTE**

1. Candidate can apply for the post through online registration of application on AIIMS, Jodhpur website: [www.aiimsjodhpur.edu.in](http://www.aiimsjodhpur.edu.in) w.e.f. 27<sup>th</sup> July, 2016 (Wednesday), as per the terms & conditions mentioned therein. The last date for applying for the post of Junior Residents (Dentistry) is 05<sup>th</sup> August, 2016 (Friday).
2. **Candidates should not send hard copy of the online application or any document thereof.**
3. The above vacancies are provisional and subject to variation. The Director, AIIMS, Jodhpur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
4. Reservation will be as per Government of India Policy.
5. 3% vacancies are reserved for physically handicapped (PH) candidates.

## **UPPER AGE LIMIT (AS ON 05/08/2016) AND ELIGIBILITY**

- a) For eligibility to apply for these posts upper age limit as on **05/08/2016** will be 30 years. This is **relaxable** for **SC/ST** candidate for a maximum period of **five years**. In the case of **OBC** candidates it is relaxable upto a maximum period of **three years**. In the case of Orthopaedics Physically Handicapped (**OPH**) candidates, this is relaxable upto maximum period of **10 years for General Category, 13 years for OBC category and 15 years for SC/ST category candidates**.
- b) **To be eligible for selection** for these posts, the candidate should pass the qualifying examination by **05/08/2016** & result should be declared to this effect on or before this date.
- c) In case of those who have appeared for exam / viva voce and result is yet to be declared then applicant will be allowed to appear in theory and/or interview provisionally.
- d) In cases where result of qualifying exam is declared after **05/08/2016**, their candidature will stand cancelled and no claim for selection on the basis of theory exam and Interview allowed provisionally will be considered.
- e) **The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview.** The candidates will not be permitted for Interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents.

## **RESERVATION FOR SC/ST/OBC/OPH SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.**

Reservation for Orthopaedics Physically Handicapped Candidates is **3%** which will be provided on horizontal basis to OPH candidate in their respective categories.

### **Criteria for Orthopaedics Physical Handicapped:**

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions and countersigned by Medical Superintendent / CMO / Head of Hospital/Institution.

**\* Candidate applying in OBC/SC/ST Category, must possess the caste certificate issued by competent authority, valid for admission/Job in Central Govt. Institutions issued before the date of interview, failing which he/she shall not be allowed to appear in interview for the same category. However, he/she can be treated as UR Candidate.**

\*OBC certificate must have been issued in last one year.

**\* Candidate should belong to non-creamy layer of Central List of OBC.**

**\* In case candidate fails to produce valid OBC certificate for admission / Job in Central Government Institution or issued within one year at the time of interview / document verification his candidature will stand cancelled.**

## **PROCESS OF SELECTION:**

1. Written examination may be conducted for screening depending upon the number of applications received.

## **TERMS & CONDITIONS**

1. The aspiring applicants satisfying the eligible criteria in all respect can submit their ONLINE application. The Online application(s) will be available on AIIMS, JODHPUR website [www.aiimsjodhpur.edu.in](http://www.aiimsjodhpur.edu.in). The candidature of such applicant s who fail to complete the online submission of application form by the stipulated date and time will not be considered and no correspondence in this regard will be entertained.
2. **Tenure:** - The tenure for the posts of Junior Residents (Dental) shall be as per Residency Scheme laid down by the Ministry of Health and Family Welfare, Government of India. The total duration of cannot be beyond tenure as Residency Scheme (Adhoc-Regular), in any circumstances including the duration of residency already rendered by the applicant in any hospital of govt. / public sector undertaking / autonomous bodies funded by the Govt. prior to this appointment, if any.
3. **Remuneration:** - The appointee will entitling to remuneration as mentioned in the advertisement.
4. **Expiry of Appointment:-** The appointment is initially for 1 year extendable further subject to satisfactory service. The appointment can be terminated at any time by the Institute. The employee can also leave the Institute by giving One Month notice or salary in lieu thereof.
5. The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.

7. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
